1. **SAFTY FIRST.** All floats or vehicles must be accompanied by walkers if any candy or favours are given out. There will be no throwing of candy or other objects allowed.
2. The Parade Committee will determine the order and location of your entry in the parade. Due consideration will be given to all but please remain in the order assigned
3. All floats with riders must have an adequate guard rail or other barrier to keep riders safe. Your float or vehicle must come to a complete stop if you need to exchange riders for walkers or vice versa.

I have read the regulations and rules of the High River & District Chamber of Commerce (hereinafter referred to as HRDCC) I, the undersigned, on behalf of the business, organization or individual represented by this entry, accept the rules and regulations as stated and agree to abide by all direction and /or decision of the Parade Committee regarding our entry and participation in the parade.
